In order to fully analyze the readiness, views, and desires of all of our school community, multiple opportunities for collaboration and input were provided which informs this plan. Feedback and input were directly collected as part of the “P.I.E. Schools Survey- Planning for Reopening.” Additional information was collected during the 2019-20 school year as part of the “School Closure Educational Support- Family Survey” as well as a “Distance Delivery- Staff Survey” in which a large number of responses were received. Informal communications as well as direct interaction with families in small focus-group sessions allowed further engagement with all members of the school community, including those often underserved and marginalized. As a part of the development of this plan, collaborative opportunities involved the Director, Administrators, and Staff.

Overwhelming support was voiced routinely, by all stakeholders, for a desire to return to in-person instruction which operates in accordance with guidance but feels as normal as possible to students, families, and staff. Students, families, and staff all voiced challenges as related to connectivity and an overall preference and desire to return to an in-person, on-site learning environment. As a rural charter school, our student population comes from a wide variety of locations. As evident during the implementation of Distant Learning for All, some students and even staff had issues pertaining to online access and reliable connectivity. In an effort to ensure equity, we must provide access for all to our educational setting.

As a small learning community, we have and will continue to reach out to all families via our school website as well as electronic and direct personal communications. Not only will our Operational Blueprint be made available to all members of our school community but we will also feature specific training of procedures, new protocol, and policies for all students, staff, and parents.

Comprehensive Distance Learning will be implemented and effective at any point during the academic school year in which metrics dictate the implementation and students will return to the in-person, on campus learning model immediately as permitted.

We recognize the hardship that is created when students are not permitted to take part in on campus learning activities during the implementation of Comprehensive Distance Learning. In alignment with other school districts in Linn county, we desire to replicate the ability to open the school building for purposes of childcare and small group instruction. This "Comprehensive Distance Learning in the Classroom" would include an instructor and a maximum of 10 students per instructional cohort. Students in cohorts would receive instruction for 2 hours per day and then return to a childcare cohort in order to ensure appropriate care and supervision for families in need of such services. During Comprehensive Distance Learning, participation in in-person instructional cohorts will be made available for all students but cannot be required.

Describe the school's plan, including the anticipated timeline, for returning to Hybrid Learning or On-Site Learning consistent with the *Ready Schools, Safe Learners* guidance.

Comprehensive Distance Learning will include synchronous and asynchronous instruction and access to learning activities which are standards-based in grade-level content areas. Google classroom and Zoom will solely be utilized as part of our instruction and Learning Management Systems. Paper-based learning packets will be distributed on a weekly basis with predetermined teacher office hours and scheduled, teacher-designed learning opportunities available.

Comprehensive Distance Learning is anticipated to be implemented and will proceed, as deemed necessary, according to the published metrics, as provided by the state. We will aggressively move to on-site instruction as our state and county metrics allow under the state and Governor's metrics guide. Caseload data of the state and county will be reviewed on a weekly basis for decision making purposes. We will maintain a distance learning component in order to support students and families.
